YOUR JANUARY VEGETABLE AND FRUIT GARDEN

- Dream & draw up your garden plan for the new season! I love this part of January the best here is how I plan and organize.
- Check your vegetable and flower seeds and then order the seeds you need this month before things start selling out.
- Check your supplies, including seed-starting mix and organic fertilizers, and replenish as needed.
- Cover any root crops still in the ground with an extra layer of mulch in freezing weather.
- Remove yellowing leaves from winter brassicas - they are no use to the plant and may harbor pests and diseases.
- Start winter pruning of fruit trees, vines, and bushes - this is best done while they are dormant. (You may want to leave plum, cherry and apricot trees unpruned until the summer to protect against silver leaf infections.)
- Prune out old growth from blackberries, raspberries, blueberries, blackcurrant bushes, gooseberries and red currants if you haven't to maintain productivity.
- Shop online or locally for asparagus roots, strawberry plants, and fruit trees (all bare-root) to plant the end of the month.
- Near the end of the month is time to weed the asparagus and strawberry beds, cutting back as needed before feeding the plants and adding to the mulch.

SHOULD YOU LIST YOUR HOME IN JANUARY OR WAIT UNTIL SPRING?

Homes Sell In Winter And Yours Can Too

If you are in the mood to sell your house, doing so in winter can actually lead to really great results. January turns out to be a fantastic time to list your house, and winter in general is coming to be accepted as a good time as any – and better than some – for selling.

Many lament over selling a home during the holidays due to how busy they are but are now tuning in to the prospect of selling in January instead.

In fact some of our agents are having this discussion right now with a few of their clients including one who lives in a mountainous area. The debate is whether they should list their home in January or wait until spring.

Of course, the thought process with most sellers is their home looks best in the spring. I could write a book about how many people tell me how awful their home looks in the winter compared to the spring. What many don't realize is everyone is in the same boat.

We took a look at home sales from 2010 through 2014 to determine how well homes sold based on the season. The findings were surprising for many people, because they went against the standard assumption that winter was a time to avoid trying to sell a home.

The Statistics Are In Your Favor

Statistics found that homes did sell best in spring, but only by a small margin. The next best time to sell a home turned out to be winter, followed by summer and then fall.

The winter home sales were only one percentage point lower than the figures for spring, with summer trailing quite a bit behind.

Homes in winter often sell quickly and for a good price, something worth thinking about if you are in the position to sell in January, February or March.

Maybe listing your home for sale now instead of waiting until spring is not a bad idea after all? All real estate markets are different but what I have found here in Central Oregon is that just before Spring is a great time to

You might be wondering why and the answer is simple. Most sellers wait until Spring to put their home on the market. All of a sudden there are a lot more houses for sale. Buyers have far more options to choose from.

If you get your house listed a bit earlier before the mad dash, you'll have less competition. There will be a pent up demand from buyers coming out of the winter months. Houses that come on in the January to March time frame tend to sell quickly.

Something you might want to consider instead of waiting until May like a lot of people do.

Bananas Foster Sticky Buns



Ingredients

- *6 tablespoons butter, divided
- *3/4 cup firmly packed light brown sugar, divided
 *2 medium-size ripe bananas, thinly sliced (about 12
- *1 1/2 tablespoons (3/4 oz.) light rum, divided
- *1/2 teaspoon ground cinnamon
- *6 tablespoons granulated sugar, divided
- *2 (8-oz.) cans refrigerated crescent rolls
- *1/2 cup butter, very softened
- *1/4 teaspoon kosher salt
- *1/2 cup plus 1 to 3 Tbsp. powdered sugar, sifted
- *1/3 cup chopped toasted pecans

Instructions

*Melt 2 tablespoons of the butter in a medium skillet over medium; stir in 1/4 cup of the brown sugar until begin to break down, 3 to 4 minutes. Set aside; let

*Preheat oven to 375°F. Stir together cinnamon, 1/4 cup of the brown sugar, and 2 tablespoons of the granulated sugar in a small bowl. Unroll 1 can of crescent roll dough on a lightly floured surface. Separate dough piece along center perforation to to seal. Repeat with remaining can.

*Spread the 4 dough rectangles evenly with the softened butter, and sprinkle each with about 2 tablespoons of the cinnamon-sugar mixture. Dollop each rectangle with one-fourth of cooled banana mixture, and carefully spread a thin layer of the rectangle, jelly-roll fashion, starting at long end.

*Gently cut each dough log into 6 even slices, using a serrated knife. Place rolls in 2 (12-cup) mini muffin pans lined with miniature paper baking cups. Bake in

*Place cream, salt, and remaining 1/4 cup each butter, brown sugar, and granulated sugar in a small saucepan over medium. Bring to a boil, whisking constantly; boil 1 minute. Remove from heat, and whisk in remaining 1 tablespoon rum. Gradually whisk in 1/2 cup of the powdered sugar until smooth. Whisk in remaining 1 to 3 tablespoons powdered sugar, 1 tablespoon at a time, until desired consistency is reached. Drizzle slightly warm buns with glaze, and sprinkle with toasted pecans

JANUARY HOME MAINTENANCE CHECKLIST

Now that the holidays are over, it's time to focus on home maintenance once again. We have compiled a handy checklist of items that need to be taken care of during this time of the year. As always, if you can't get to any of these tasks, call on our sister company, Fieldstone Property Maintenance to handle them for you!

- 1. Replace filters or wash permanent ones in your HVAC system and humidifier. Filters should be cleaned or changed monthly during peak season (based on filter type no longer than 3 months).
- 2. Vacuum all heat vents.
- 3. Inspect, clean and test smoke and carbon monoxide detectors. January is a good time to replace the batteries in all your detectors. Check with your local fire department on where to install smoke and carbon monoxide detectors in your home.
- 4. Make sure you have properly charged and working fire extinguishers in your home. Consider placing within easy access to the kitchen, garage, furnace/boiler room, fireplaces and wood stoves.
- 5. Have a plan of action in place for the whole family to exit safely during a fire. Set a place to meet outside so you can count heads. Have practice fire drills, especially if you have kids!
- 6. Check for leaks in forced air heat duct joints and seal with duct tape.
- 7. Look for indoor condensation on windows and take corrective action.
- 8. Check electrical outlets for drafts and install foam gaskets to seal them.
- 9. Check and test GFCI outlets to make sure they are working properly.
- 10. Check snow removal equipment, shovels, ice melt etc. Make sure you have enough gas and or propane on hand to operate removal equipment or emergency generator if needed.
- 11. Pick one room in your home and organize it...de-clutter and call us to install a shelving system.
- 12. Review recommended maintenance for furnace, equipment, appliances, and tools. Mark your calendar to track scheduled upkeep and service.

Beyond Bees

I often share information about how to identify beehives and what is needed to check out a property around them for the general public. I was just picking up fresh eggs from a neighbor and saw some bee gear on the side of their home. It's something to know if you don't want to live next to a neighbor with bees and chickens. I can hear the roosters crowing in the distance.

Inspired by a recent post from a family trying to sell their property in, what has been a very lovely and desirable neighborhood, I'm pivoting away from bees this month. There was a property in that very neighborhood I would have loved to land when I was searching for a home for myself in Central Oregon. Unfortunately, there was a lot of interest, actually a dog-pile for it and I was out bid.

The family trying to sell their lovely home in that beautiful neighborhood have had two Buyers back out of the sale during the due diligence period, likely due to a homeless camp that has popped by nearby. When the family bought their home many years ago, the adjacent area was forest, and still is public lands. No one could have foreseen the future of what is now the nearby homeless camp and the problems that came with it, I feel for them.

In the search for my home, I had made offers on 4 other bank-owned properties before landing mine. 3 of them were in established neighborhoods, 1 of those was adjacent to public lands and 1 had an easement due to a lovely canal in the back of the property. I thought about what had become of those other properties after reading the post. Three of them needed TLC. Two of those three, that were in established neighborhoods, are clearly now lovingly maintained. The third, the property with the canal, was sadly snapped up by a higher bidder who was willing to pay up for it. I really wanted that property; the enchanting canal had been there for decades and had become naturalized with abundant wildlife. But as it turned out this lovely property too would have significant changes.

What happened? Due to several years in a drought cycle, in an effort to preserve water, the little canal is being channeled into a large pipe to carry it into areas in need of the precious resource. Back then, I would not have anticipated the little canal that drew me to the property would be piped and buried, or that if I'd made my home there, would be spending money with my neighbors to fight a losing battle to keep it.

I was an expert in the bank-owned dog-piles by the time the home I landed came up for sale. Neighbors have since come and gone, some less desirable then others, and beautiful new homes have been built around mine. While not perfect, of the homes available back then, this one has had few surprises, but I'm watching and listening.

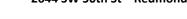
